2013 RETIRED MEMBERS' GATHERING

The 12th annual MTA Retired Members Gathering featured a vibrant mix of celebration, activism and education, drawing roughly 200 retired members to the event in Marlborough. The day was divided up into seminars on topics ranging from pensions, financial

and legal planning to political mobilizing; reports from the MTA's Retired Members Committee on issues of concern for educators past and present; and recognition for decades of service by Dr. Richard Lyons and Retired Members Committee Co-Chair Kathleen Roberts.

Lyons received the "Honoring Our Own" award. Lyons was president of the first faculty association to represent educators at what is now UMass Lowell, and he served the union in various capacities throughout his 36 year career. "Roberts was genuinely surprised when her committee cochair, Richard Liston, interrupted lunch to present her with a plaque honoring her many contributions – to the MTA, to education and to her community. Liston also read



Roberts, who recently turned 99, a birthday greeting sent from Senator Elizabeth Warren and MTA Vice President Tim Sullivan led the luncheon crowd in singing "Happy Birthday" to her.

Liston outlined MTA's accomplishments in recent elections and noted the challenges that lie ahead, particularly the need for retirees to stay active in political campaigns and follow legislation affecting their lives and their profession. "We have to fight for ourselves," he said. "We can't rest on our laurels. We need as much vigor, passion and involvement in the fall 2014 race for governor and Senator Markey's race."

WHAT DOES DETROIT MEAN FOR MASSACHUSETTS?

A recent decision concerning the City of Detroit. Detroit, in which a federal judge has issued a ruling that, in effect, permits the municipality to proceed with the largest municipal bankruptcy in U.S. history, has created a buzz across the country. Similarly, pension funding problems in Illinois have also been in the news, and with these stories the question that comes up is whether or not public pensions will continue.

To understand the situation one must first look at the specifics to ascertain what factors were in play. Clearly, the financial problems facing Illinois and Detroit are significant, but whether those conditions translate across the entire country is not necessarily true. First the financial problems in Detroit has, in no small measure, coincided with changes in the industrial landscape and tax base, as well as with skyrocketing financial costs for loans, and corporate subsidies and tax loopholes. Pensions are not the main problem inasmuch as the average pension is \$19,000 per year for most employees and \$30,000 per year for police and firefighters, who are not eligible to receive Social Security. Illinois has systematically not funded its pensions and passed changes to its statute to reduce future benefits for current employees and putting in place a plan to pay off the system's unfunded liabilities.

In Massachusetts workers' pay a percent of their wages into their respective retirement systems, (figures can vary based on hire date), and receive potential benefits based on 3 basic factors: their age at retirement, years of creditable service, and the worker's average salary over a specific period of time. Public employees in Massachusetts are not covered by Social Security Most employees retiring today paid a far higher percentage into their retirement system that any private sector worker, and, in addition, there was no contribution on each dollar earned by the employer (currently 6.2%).

In Massachusetts, at present, there is no evidence of a possible default, unlike the situation in Michigan, so our situation is different. In addition, the state system has been held to set up a contractual relationship between public employee retirement system members and the state.

The Supreme Court has I opined that the pension law established a contractual relationship between the employee and the state in that the law generated "material expectations on the part of employees and those expectations should in substance be respected", and that the meaning of a contractual expectation may not deprive members of the core of reasonable expectations that existed when they started in the system. So while other parts of the country are experiencing problems, the current statutes, and current decisions by the courts, provide some level of security for public employee pensioners in the state.

OPEB HEARING

Ardner Auditorium of the State House was packed on October 31 with public employees, state and municipal leaders, retirees and legislators testifying for and against House 59, the Governor's bill to reduce the unfunded liability for retiree health insurance by changing certain eligibility requirements and increasing the health insurance premium share paid by some future retirees. MTA President Paul Toner acknowledged that there is a serious fiscal issue regarding other postemployment benefits – or OPEB

- and that the MTA is in a "bind" on this issue because the association wants to protect benefits for current employees but also wants to support a sustainable system capable of providing benefits to retirees in the future as well as prevent future layoffs and service cuts.

TOOLS 4 TEACHING 'STORE' IS PRICED RIGHT FOR SPRINGFIELD EDUCATORS

Retired Springfield educator Chris Williams remembers cringing whenever she saw perfectly good classroom materials tossed into a dumpster, and after seeing a television news story about a Florida school district that took in donated pens, notebooks and other materials from businesses to make them available to teachers for free, Williams thought that Springfield should do not just the same, but better.

Williams and the rest of the Springfield Education Association's Committee of Retired Teachers added the important component of recycling, diverting usable materials both purchased and homemade - and getting them into the hands of teachers. The Tools 4 Teaching "store" opened on Sept. 19, stocked with books, posters, markers, construction paper and the like, all donated by local businesses or teachers who had retired or were taking on new assignments where they would no longer need the accumulated materials. WASHINGTON UPDATE

As a result of Massachusetts' decision to not bring public employees under Social Security, public workers in the state are hurt by two pieces of federal legislation that can reduce, or eliminate certain benefits under the Social Security Act that have been earned by an individual or a spouse. The Social Security Fairness Act (H.R. 1795/S. 896), which was filed in both branches of Congress last spring, seeks to correct this inequity.

This legislation would repeal the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO) that impact over one and one-half million Americans who have been public servants, and that number will continue to increase over time. The GPO, in many instances, eliminates or all but eliminates, spousal benefits for public employees, while the WEP requires 30 years of substantial earnings for a public employee to obtain their full social security benefit.

ATTENTION HIGHER ED RETIRED MEMBERS!
